

Hamlin Town Board Meeting  
February 28, 2018

The Hamlin Town Board held their regular meeting in Hamlin Town Hall Located at 1658 Lake Road, Hamlin New York. The meeting was called to order at 7:00 by Supervisor Eric Peters. The locations of the fire exits and defibrillator were explained to those present. Everyone was invited to participate in the Pledge of Allegiance and a moment of silence for the deceased residents of Hamlin.

**PUBLIC FORUM:** Bob Jones of 7561 Sandy Harbor addressed the board. He is also the Sandy Harbor Beach Association's President. He built his home in 2016 and since the flooding has begun there has been over \$60,000 in damage to his home. This damage prevented him from living in his home for 3 months. He anticipates the flooding to continue this year and wanted to know if the Town had a plan. The Town of Kendall is using aqua dams and the Town of Greece is building berms. He was putting sand and dirt fill to build up his yard, which he believed to be okay. He received a stop work order. He is receiving mixed messages from the Town and the DEC and he is confused. He would like to protect his home.

**Reports**

Superintendent Steve Baase reported on the following:

- FEMA- Seems willing to help and confident for our approval. Still in the beginning process of the application. Compiling estimates to submit by the March 9<sup>th</sup>, 2018 deadline. The information needs to be broken down by road and amount of damage.

Supervisor Eric Peters reported on the following:

- Recovery Now Program-Eric Spoke with Gates Town Supervisor Mark Assini. Gates has been running this program since last year. They provide a space at their facility to meet 2/3 time a week. Mostly family members are the ones who attend not usually addicts unless they are progressing towards the end of their recovery process. Sometimes councilors or outside agencies are there to assist. Gates has not had any issues hosting this program. Anke has the space and sees no problem allowing this program to start up in Hamlin.
- The fourth quarter sale tax check was received. It was about \$18,000 more than the same quarter in 2016.
- Eric attended the Town Supervisors Meeting. Cheryl Dinolfo presented on the Redwings, The Zoo and the Airport projects.
- Invitation for the Monroe County Capital Project Presentation on March 5<sup>th</sup> 2018.
- Reserved Town Hall Area/Field on July 28<sup>th</sup>, 2018 for the Sandy Creek Shoot Out. With 200 participants, the hope is to increase lunch traffic at Hamlin establishments.

#### DISCUSSIONS:

Cheryl discussed the Sandy Harbor Beach Association requirements for the DEC. The DEC requires the association to have a plan on what they want to do. Then each person needs to submit a plan for how to complete their part of the whole project. She has been told by the DEC if even one person does not want to do it then it will not be approved by the DEC. She has been trying to help people as much as possible. Jason requested more information on the required DEC permits. Jennifer asked about the Kendall aqua damns. Kendall is part of Orleans County which often gets more funding due to the demographics.
