

PUBLIC HEARING AND  
SPECIAL TOWN BOARD MEETING  
FOR THE 2011 PRELIMINARY BUDGET

November 1, 2010

A Special Town Board meeting was held in the Hamlin Town Hall located at 1658 Lake Road, Hamlin, New York. The meeting was called to order at 6:30 pm by Supervisor Terry.

Present: Councilperson Thomas Breslawski, Councilperson Craig Goodrich, Councilperson Paul S. Rath, Councilperson David Rose, Supervisor Peter Terry.

Also present: Highway Superintendent Steven Baase; Building Inspector Lee Nettin; Planning Board Member Tom Jensen; Library Director Kay Hughes-Dennett; Conservation Board Member Jason Baxter; and Resident Bob Kruger.

Supervisor Terry stated the purpose of the Public Hearing is to review the 2011 Preliminary Town of Hamlin Budget. Supervisor Terry asked the Town Clerk to show proof of publication. Supervisor Terry invited comments and questions.

Councilperson Rath stated that it was a tough process this year. Thanks to the Highway Department, we appreciate some of the bigger sacrifices, especially looking at the long term.

Councilperson Breslawski stated, we put a lot of hours in and it was a very challenging budget year this year.

Highway Superintendent stated that since the Highway Department has the largest budget (approximately 1 ½ million), next year he would like more than 24 hours to review the budget and state his case before it is finalized.

Councilperson Goodrich asked if yearly performance reviews are done for all employees, and should mid-year reviews be done.
